School of Global Policy & Strategy <u>Fellowships & Financing</u> and <u>Military & Families</u>. You may be required to complete and submit the FAFSA to be considered for some types of graduate awards. FAFSAs are available beginning October 1st every year.
- Students who are unable to complete the FAFSA and/or California Dream Act Application or who are enrolled in less than half-time (6 units), may be able to apply for a private loan. <u>Private Education Loans</u> are available for domestic and international students. - <u>GPS 24-month Full-Time MCEPA Program</u> students pay \$36,106 program costs. The 24-month Full-Time MCEPA Program requires 96 units for completion.
