International students may apply for [Private Education Loans](#) to assist with educational costs.
4. The COA above is based on a student living off-campus. A student living on-campus or living with a parent will have a different COA and can refer to the graduate student cost of attendance budgets for the various components and costs [Graduate Students Cost of Attendance \(ucsd.edu\)](#).
5. [GPS Full-Time 2-Year MCEPA Program](#) students pay \$37,007 program costs. The Full-Time, 2-Year MCEPA Program requires 96 units for completion.

You may be required to complete and submit the FAFSA to be considered for some types of graduate awards. FAFSAs are available beginning October 1st every year.
 - Students who are unable to complete the FAFSA and/or California Dream Act Application or who are enrolled in less than half-time (6 units), may be able to apply for a private loan.
