International students will also be billed a one-time [International Student Visa Administration fee](#) of \$100. International students may apply for [Private Education Loans](#) to assist with educational costs.
4. The COA above is based on a student living off-campus. A student living on-campus or living with a parent will have a different COA and can refer to the graduate student cost of attendance budgets for the various components and costs [Graduate Students Cost of Attendance \(ucsd.edu\)](#).
5. [GPS Full-Time 9-Month MAS-IA Program](#) students pay \$900 per credit unit. The Full-Time 9-Month MAS-IA Program requires 48 units for completion.

You may be required to complete and submit the FAFSA to be considered for some types of graduate awards. FAFSAs are available beginning October 1st every year.
