Inquire at the Financial Aid and Scholarships Office for lenders that accept international applicants. Your Major Department and/or the <u>Graduate Division</u> may provide other forms of financial support. School of Global Policy & Strategy <u>Fellowships & Financing</u> and <u>Military & Families</u>. You may be required to complete and submit the FAFSA to be considered for some types of graduate awards. FAFSAs are available beginning October 1st every year.
- Students who are unable to complete the FAFSA and/or California Dream Act Application or who are enrolled in less than
 half-time (6 units), may be able to apply for a private loan. <u>Private Education Loans</u> are available for domestic and
 international students. Inquire at the Financial Aid and Scholarships Office for lenders that accept international applicants.
- <u>GPS Full-Time MPP Program</u> students pay \$17,385 tuition and fees. The 24-month Full-Time MPP Program requires 92 units for completion.
