- The Cost of Attendance (COA) does not include the <u>Document fee</u> of \$100. COA and award packages are automatically adjusted for incoming students.
- 2. The Cost of Attendance (COA) includes the \$150 annual Rady Student Activity fee.
- The Cost of Attendance (COA) includes the UC Student Health Insurance Plan (SHIP) of \$3,855. Students may opt out of the UC Student Health Insurance Plan. For additional UC SHIP information, visit https://shwadmin.ucsd.edu/uc-ship/index.html.
- 4. Non-California resident and international students are not charged a Non-Resident Supplemental Tuition cost. Non-California residents will be considered for <u>Federal Direct Loans</u> only. International students will also be billed a one-time <u>International Student Visa Administration fee of \$100</u>. International students may apply for <u>Private Education Loans</u> to assist with educational costs.
- 5. Books and Supply costs are included in each term's fees amount and are provided to each student.
- Students may submit <u>Cost of Attendance Add-On forms</u> with appropriate documentation for rent and utilities, transportation costs, computer purchases and/or increased books and supplies. <u>Submission of a request does not guarantee an approval.</u>
- Financial Aid and Scholarships Office provides Federal Direct Unsubsidized and Federal Direct Graduate PLUS Loans and requires the Free Application for Federal Student Aid (FAFSA). Private Education Loans are available for domestic and international students. Inquire at the Financial Aid and Scholarships Office for lenders that accept international applicants. Your Major Department and/or the Graduate Division may provide other forms of financial support Rady Master of Finance costs and financing. You may be required to complete and submit the FAFSA to be considered for some types of graduate awards. FAFSAs are available beginning October 1st every year.
- Students who are unable to complete the FAFSA and/or California Dream Act Application or who are enrolled in less than
 half-time (6 units), may be able to apply for a private loan. <u>Private Education Loans</u> are available for domestic and
 international students. Inquire at the Financial Aid and Scholarships Office for lenders that accept international applicants.
- Rady Master of Finance students pay \$1,320 per credit unit. The academic year is based on 16 credit units Fall term, 16 credit units Winter term, and 16 credit units Spring term and 8 credit units Summer term. Actual units taken may vary based on each student's enrollment. The 12 or 15-month Rady Master of Finance Program requires 52 credit units for completion.
