3. Non-California resident and international students pay non-Resident Supplemental Tuition (currently \$29,754 annually) in addition to charges paid by California resident students. To assist with educational costs, non-California residents will be considered for federal aid only: [Federal Pell Grant](#), [Federal Work-Study](#), and [Federal Direct Loans](#). International students will also be billed a one-time [International Student Visa Administration fee](#) of \$100. International students may apply for [Private Education Loans](#), to assist with educational costs.
