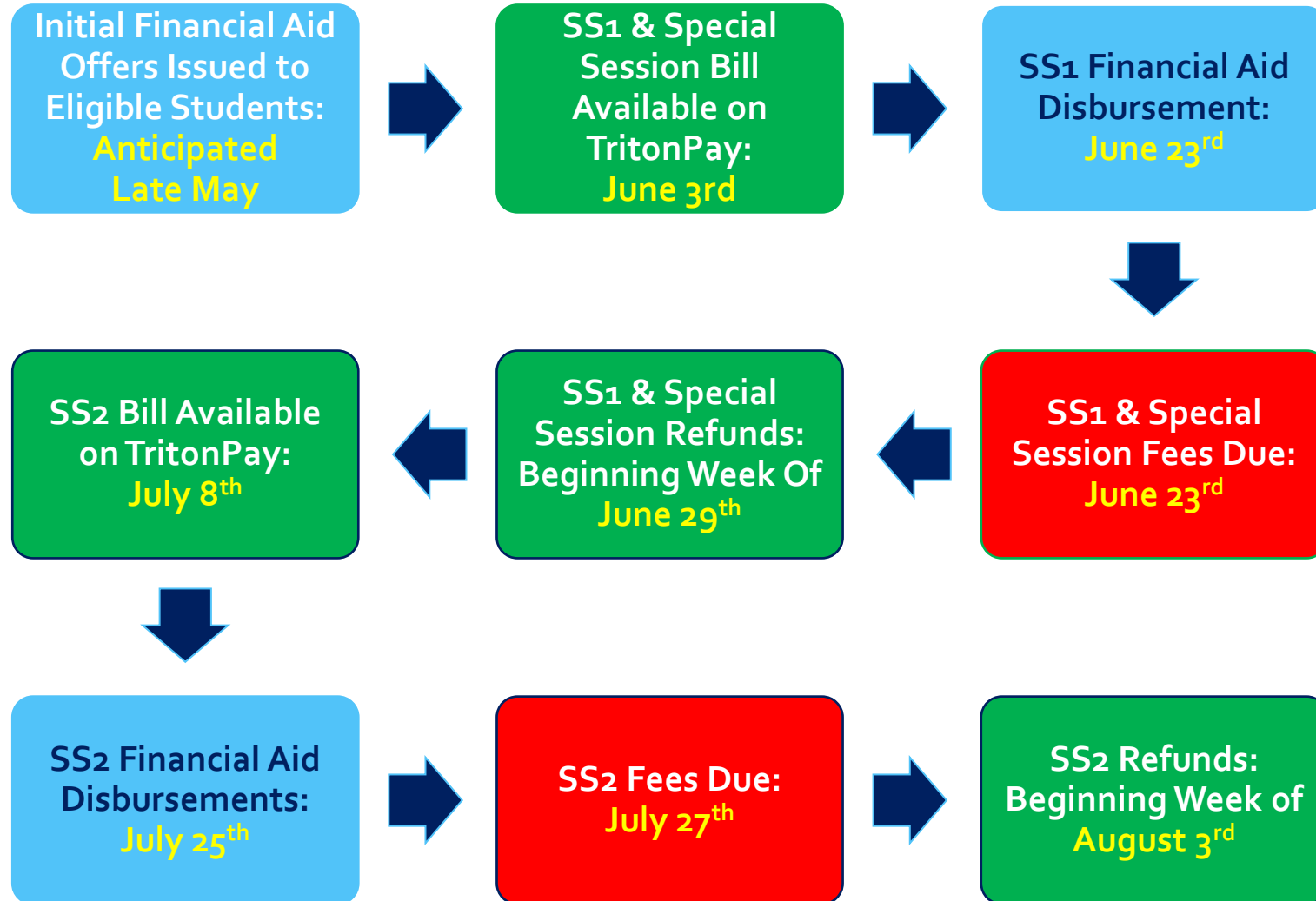

Summer 2026: Tuition and Fees

Tuition:

- Undergraduates: \$291.00 per unit
- The same price is charged regardless of out of state, non-residential, or international student status

Campus Based Fees:

- Undergraduates: \$295.24 per Session
 - University Center Fee: \$57.03 per session
 - RIMAC Facility Fee: \$50.00 per session
 - Canyonview Facility Fee: \$11.00 per session
 - Intercollegiate Athletics Fees: \$177.21 per session

Material Fees:

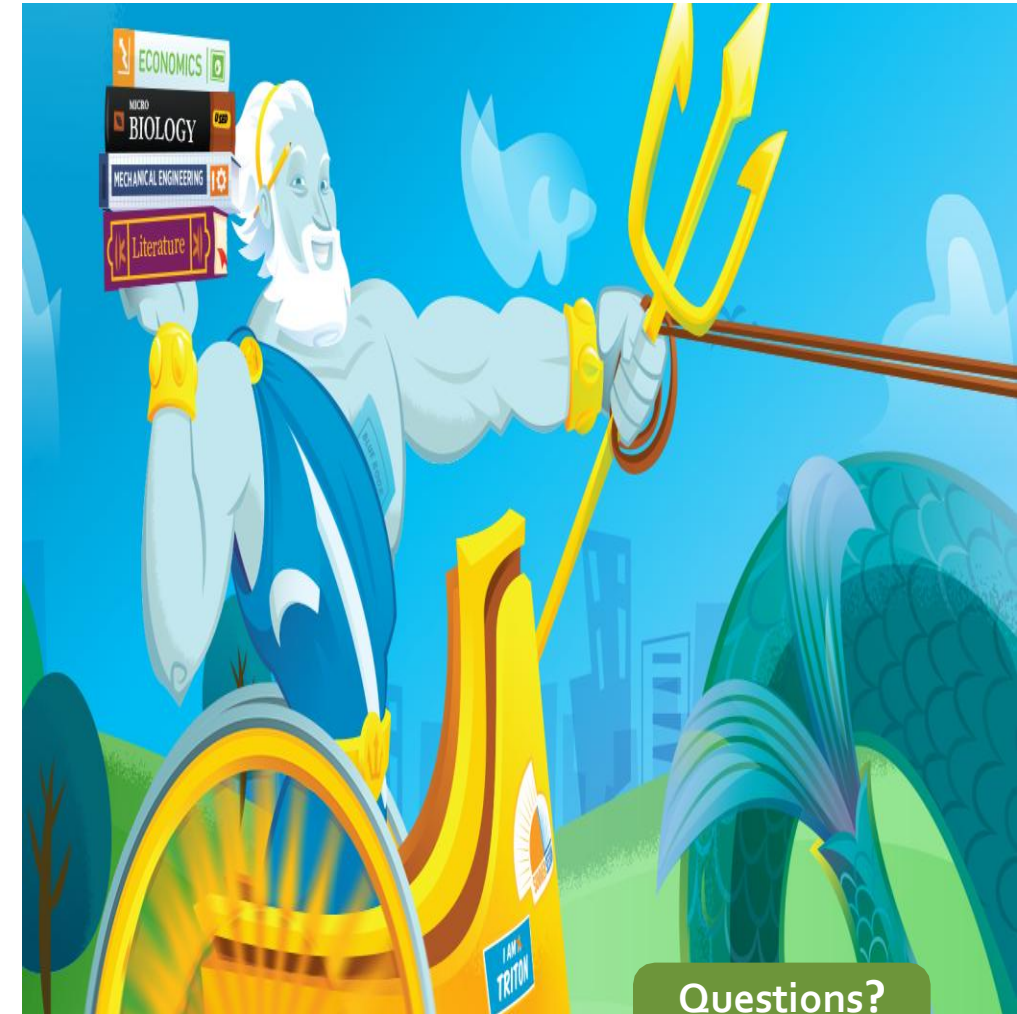
- Some courses may require material fees; all students enrolled in those courses must pay the material fee. Please refer to the course description on the [Schedule of Classes](#)

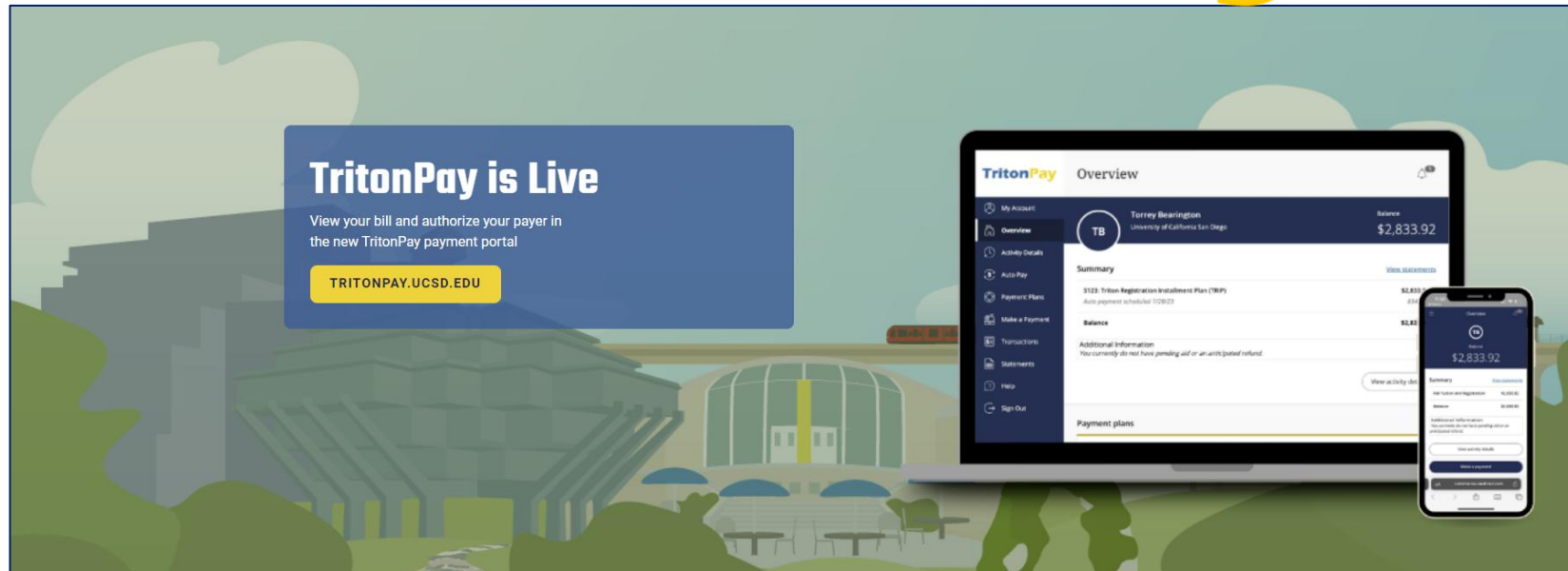

- **Accepted and completed Summer financial aid**
 - Disburses evenly over all enrolled sessions

 - Disbursed aid goes towards the balance due
- **Special Session 2026 disbursement:**
 - Approximately 2 days before the first day of instruction, adjusted if enrolled in multiple sessions

 - Week of July 20st, 2026
 - Week of August 10th, 2026
- 6+ Units required
 - Waitlisted units don't count towards enrolled units

Loan processing time

- Allow up to 1-2 weeks processing time for certification and disbursement of accepted Private, Direct, Dream and University loans

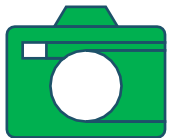
