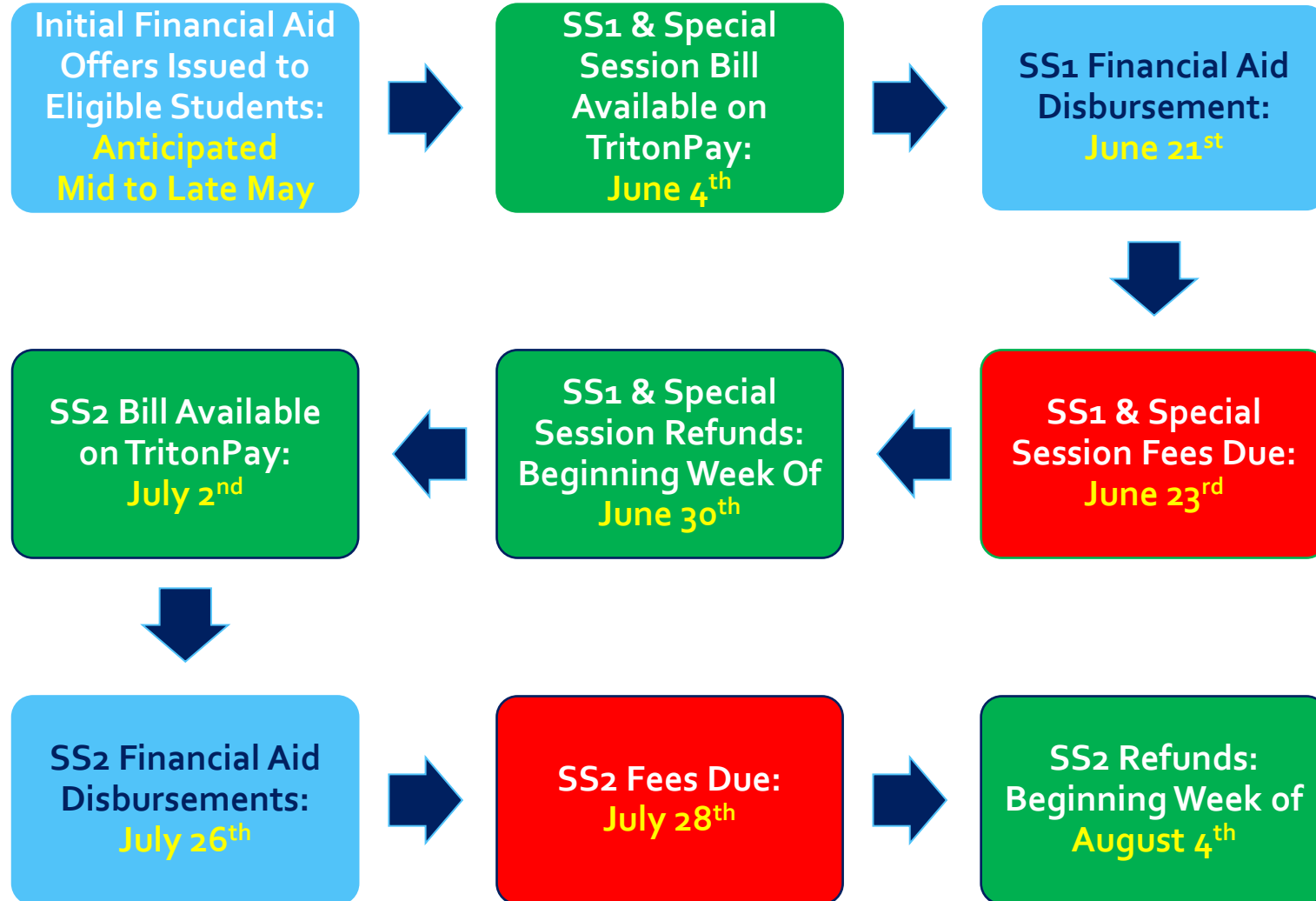

# Summer 2025: Tuition and Fees

## Tuition:

- Undergraduates: \$279 per unit
- The same price is charged regardless of out of state, non-residential, or international student status

## Campus Based Fees:

- Undergraduates: \$288.49 per Session
  - University Center Fee: \$55.43 per session
  - RIMAC Facility Fee: \$50.00 per session
  - Canyon View Facility Fee: \$11.00 per session
  - Intercollegiate Athletics Fees: \$176.06 per session (undergraduates only)

## Material Fees:

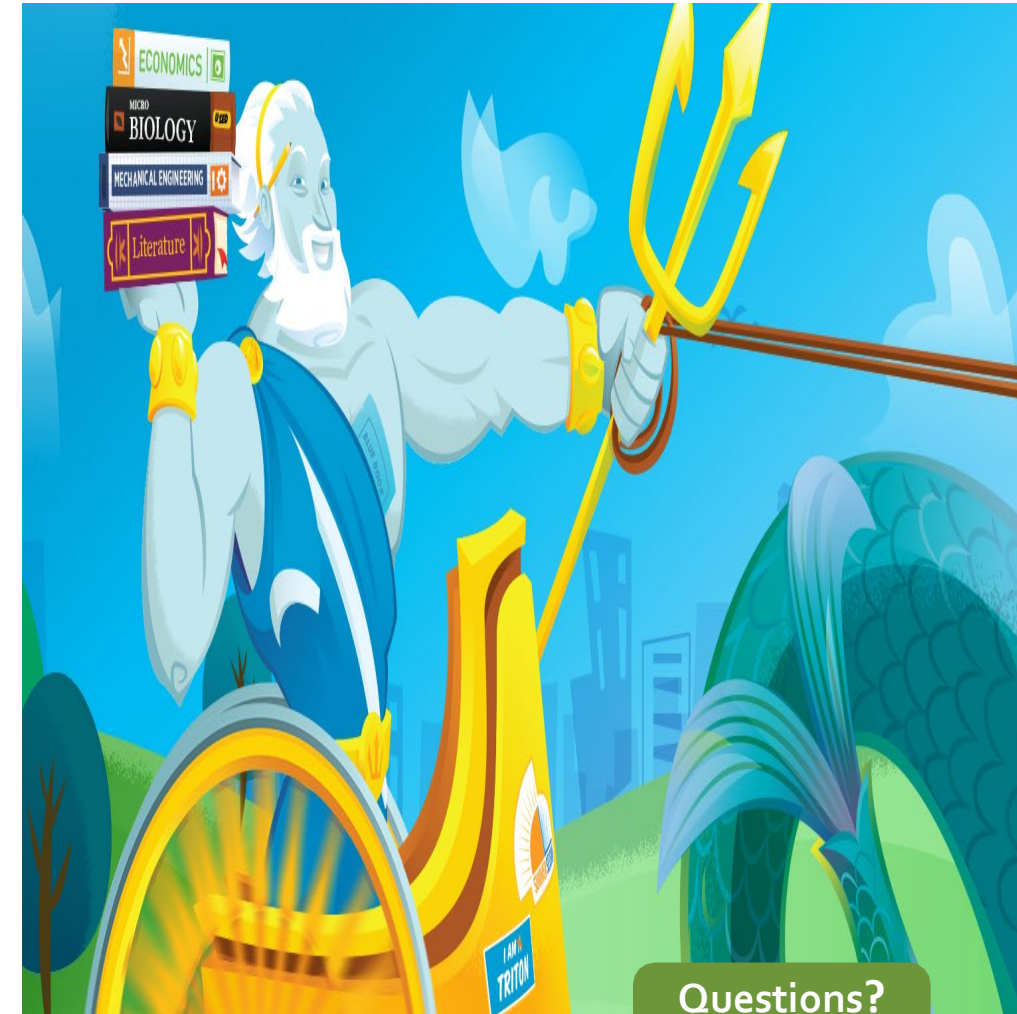
- Some courses may require material fees, all students enrolled in those courses must pay the material fee. Please refer to the course description on the [Schedule of Classes](#)

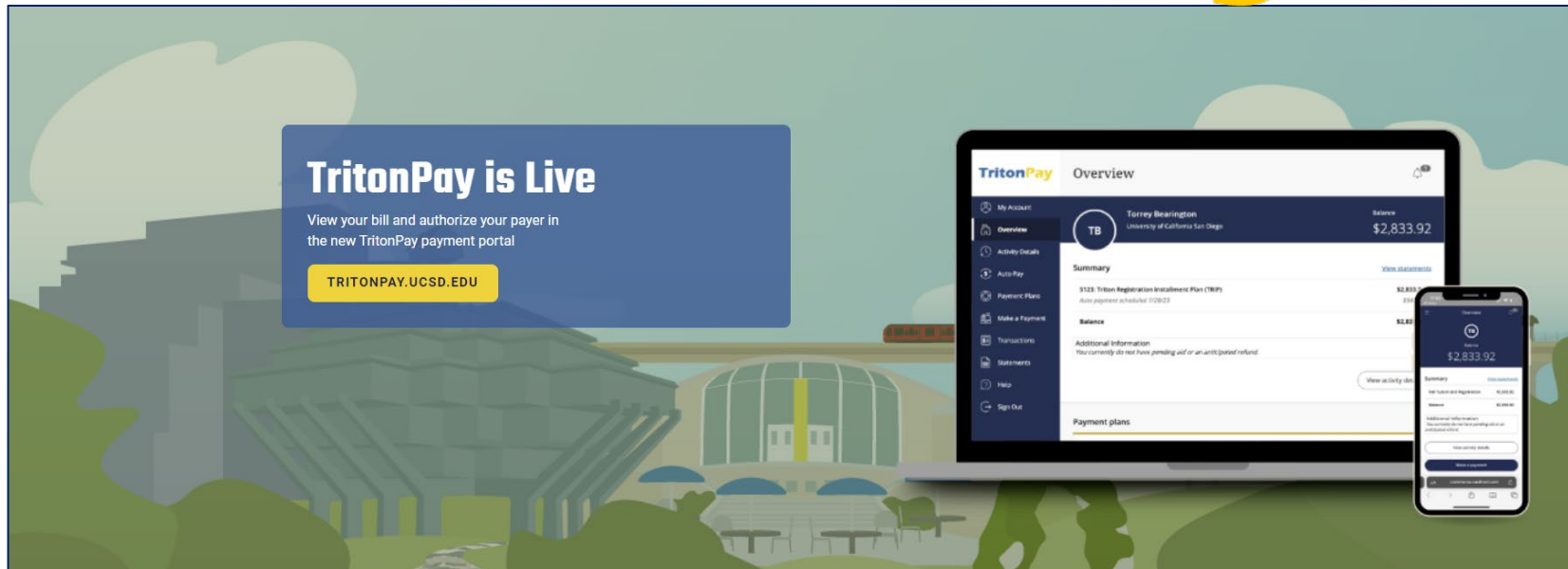

### Authorize a Payer

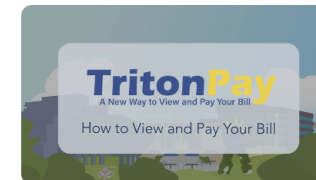
- Students can authorize payers on Tritonlink

- **Accepted and completed Summer financial aid**
  - Disburses evenly over all enrolled sessions
    - Your Summer Session courses are charged per unit
    - This may result in different balances owed each session if enrolled in multiple sessions
  - Disbursed aid goes towards the balance due
- **Special Session 2025 disbursement:**
  - Approximately 2 days before the first day of instruction, adjusted if enrolled in multiple sessions

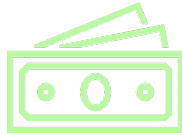

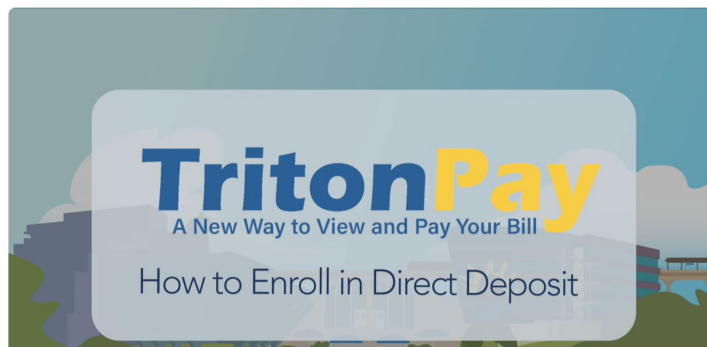

# Why didn't my financial aid disburse?

## Enrollment updates

- Changes in your summer Enrollment will delay processing
- Changes may also result in a balance owed
- Please note our scheduled financial aid adjustment points
  - Anticipated Summer Aid Adjustment Schedule\*
    - Week of June 16th, 2025
    - Week of July 7th, 2025
    - Week of July 21st, 2025
    - Week of August 11th, 2025
- 6+ Units required
  - Waitlisted units don't count towards enrolled units

## Loan processing time

- Allow up to 1-2 weeks processing time for certification and disbursement of accepted Private, Direct, Dream and University loans

## Satisfactory Academic Progress ( SAP)

- Students must meet SAP GPA, Pace, and maximum timeframe requirements
- Appeals are available in the Financial Aid Document section of MYTritonLink for those students that opt to appeal their SAP status
