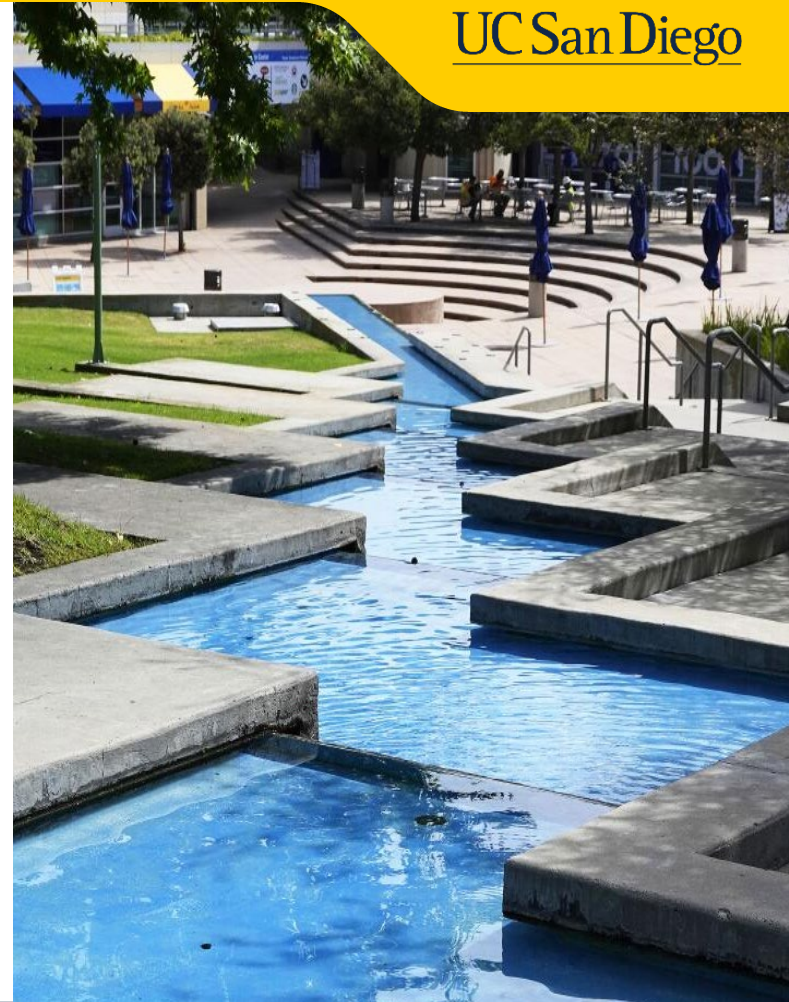

## \*DREAM

- The [California Dream Act](#) application is available to those that qualify for the AB540 fee exemption and are not permitted to file a FAFSA.

# Summer 2025: Student Aid Index (SAI)

## What is a SAI?

- The [Student Aid Index \(SAI\)](#) is an index number used to establish your financial aid offer. Your SAI is calculated using information that you (and other contributors, if required) provide on the *Free Application for Federal Student Aid* (FAFSA) or California Dream Application (DREAM)
- A student's financial aid need is determined by subtracting the SAI from their total cost of attendance
  - Need determines a student's estimated eligibility for aid

## What is the source of data used in SAI calculations?

- The SAI is based on a formula that considers income, assets, and family size as reported on your aid application
- The SAI range is -1500 to 999999
  - A negative SAI indicates higher financial need



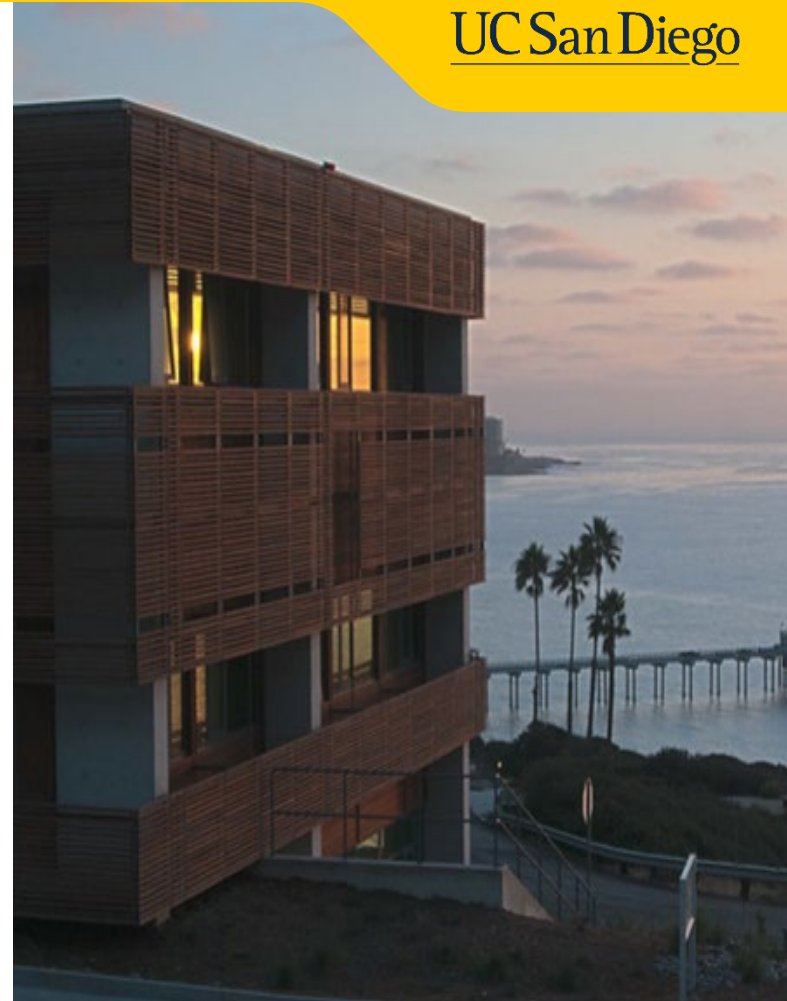
# Summer 2025: SAI, COA, and Need Determination

## What is Academic Year financial aid “Need”?

- Academic Year “Need” is the difference between the [UC San Diego cost of attendance](#) (your estimated costs) and your student aid index (SAI), as determined by your FAFSA or DREAM application
- Students with Academic Year “Need”, a valid 24-25FAFSA or DREAM application, a valid SAP status, and meet the Summer Session enrollment requirements will be considered for a summer aid offer

## What is Summer “Need”?

- Summer “Need” is the difference between your [UC San Diego summer cost of attendance](#) and your student aid index (SAI), as determined by your FAFSA or DREAM application





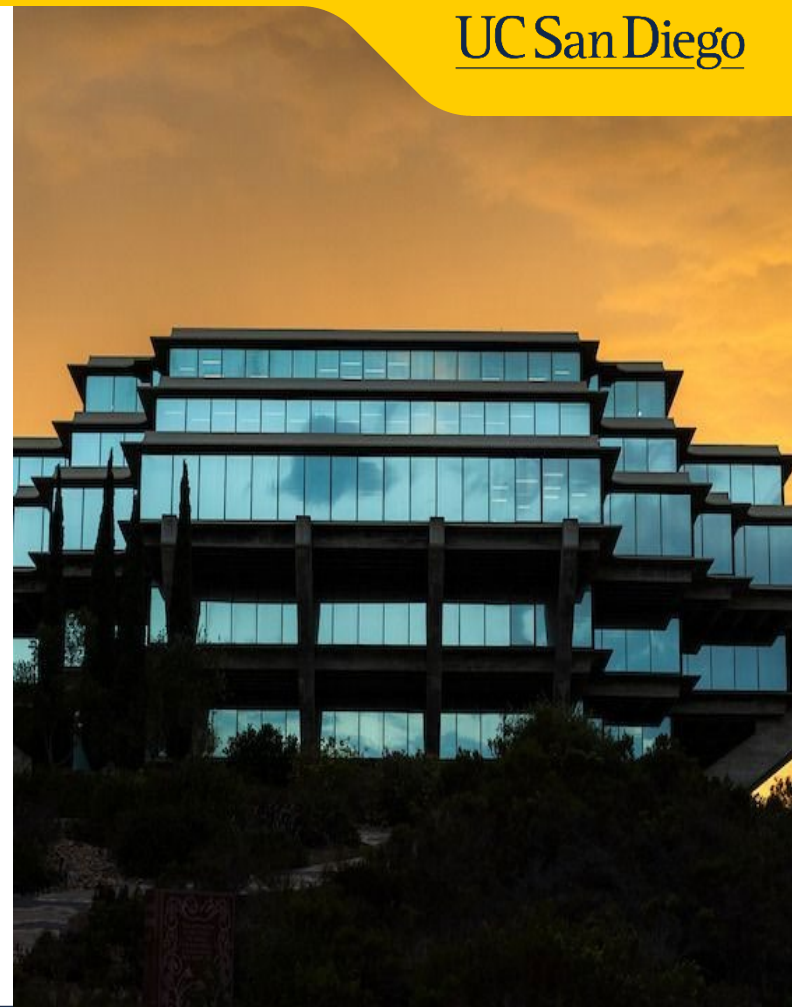
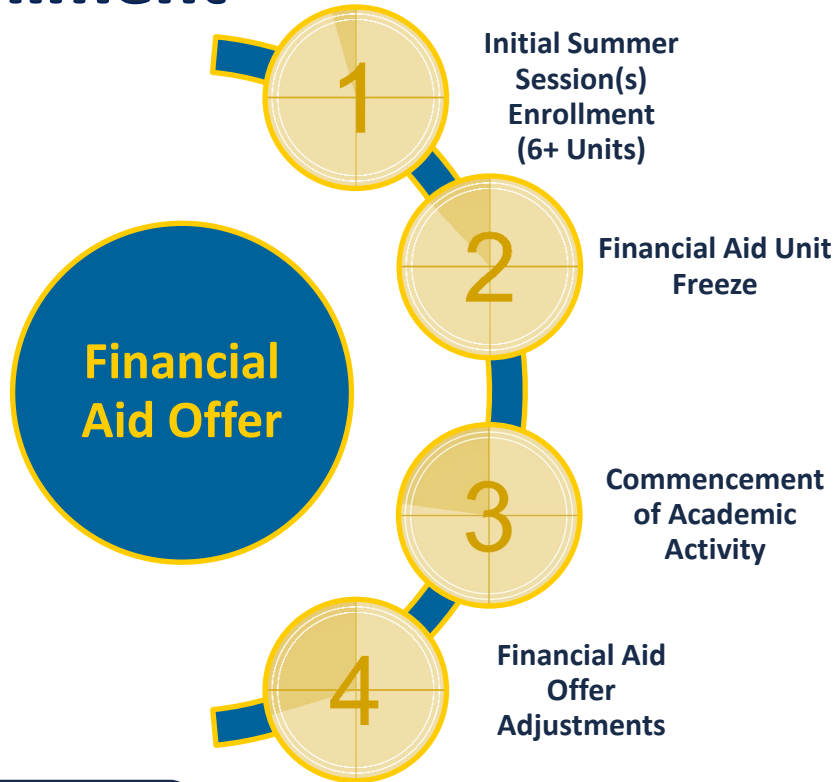

# Summer 2025: Enrollment

## Enrollment Requirements

- Enrollment in the winter 25 and/or spring 25 term(s)
- Have pending degree requirements at the end of the Spring 2025 term
- Not academically dismissed
- Not a Fall 2025 Re-Admitted student
- Enrollment in 6+ Summer Session Units
  - This can be a combination of UCSD Summer Session or other valid UC summer courses
- Waitlisted Units **DO NOT** count towards enrolled units
- Your initial financial aid offer is based on your enrolled summer units at the time of the offer

## Financial Aid Determination of Units

- Your final units for Summer Session are determined by the units you are in at the stated financial aid unit freeze date & the verification of those units by your instructor via the Commencement of Academic Activity process
- Your aid is adjusted to account for changes in validated Summer Session units



# Summer 2025: Enrollment

## Financial Aid Unit Freeze Dates

- Your financial aid units will lock on the dates listed on the upcoming slide
- This date is determined by your session(s)
- Your financial aid will adjust if these units are different than the units at the time of your initial award offer
- **This may result in a balance on your account that you will be billed for**

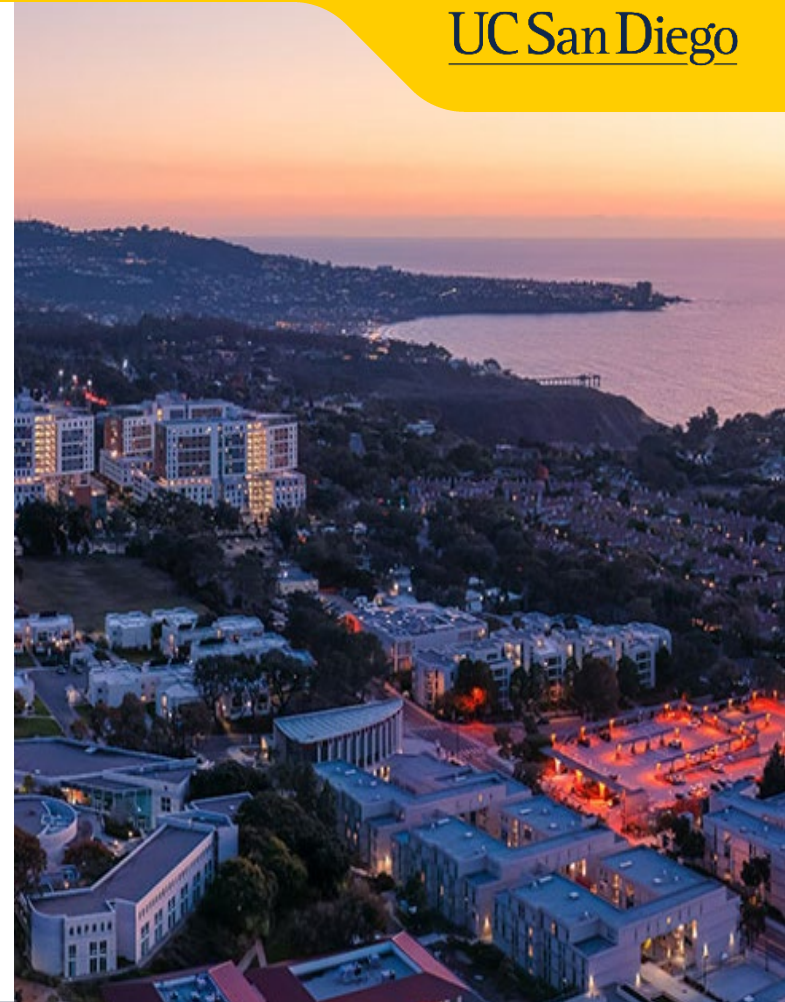

## Commencement of Academic Activity (CAA)

- At the start of each Summer Session, instructors must document that their students have commenced academic activity in their course to validate units
- Unvalidated units may result in a loss of financial aid

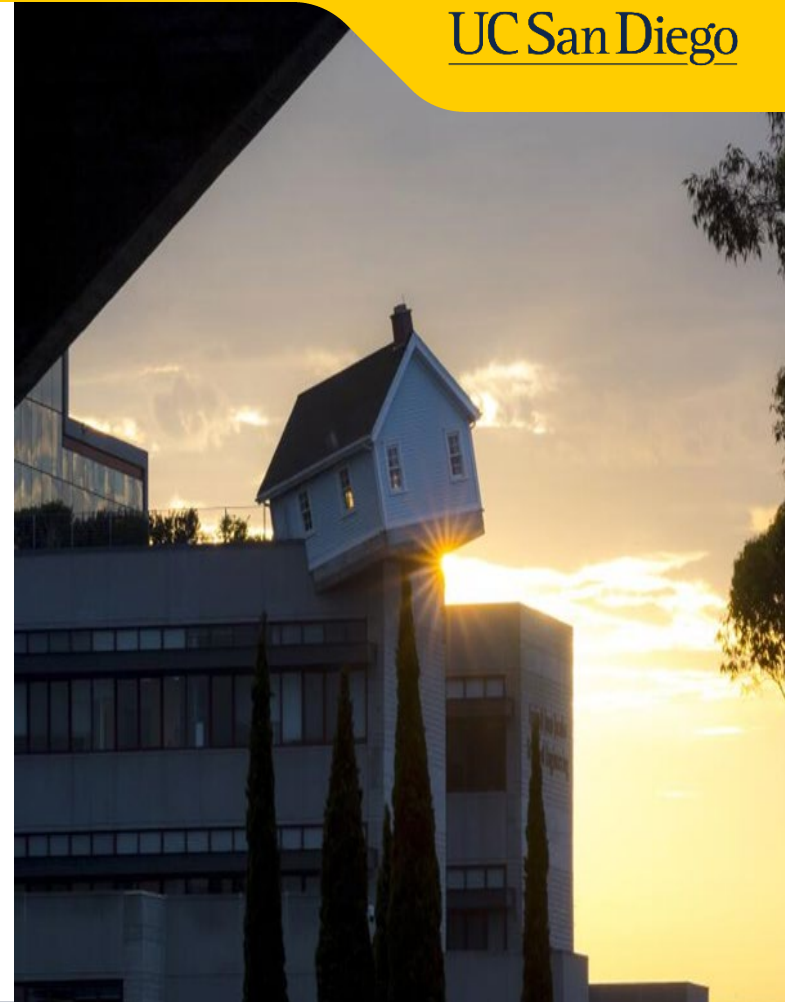
- **If you add / drop units and/or otherwise change your schedule / enrollment**
  - Please consider the impact of your financial aid prior to making enrollment changes
- Your instructor does not certify your units via Commencement of Academic Activity
- These changes may cause:
  - **Delays in the processing of your awards**
  - **Summer Session balances and bills from a reduction in financial aid**



# Summer 2025: Enrollment

## Complete Withdrawal From Summer Session

- Students that withdrawal from all sessions are subject to a financial aid refund calculation
- This calculation is based on the time of attendance in the applicable summer session
- Financial aid is adjusted based on the refund calculation
- Note that this calculation may result in **Summer Session balances and bills from a reduction in financial aid**

# Summer 2025: Satisfactory Academic Progress (SAP)

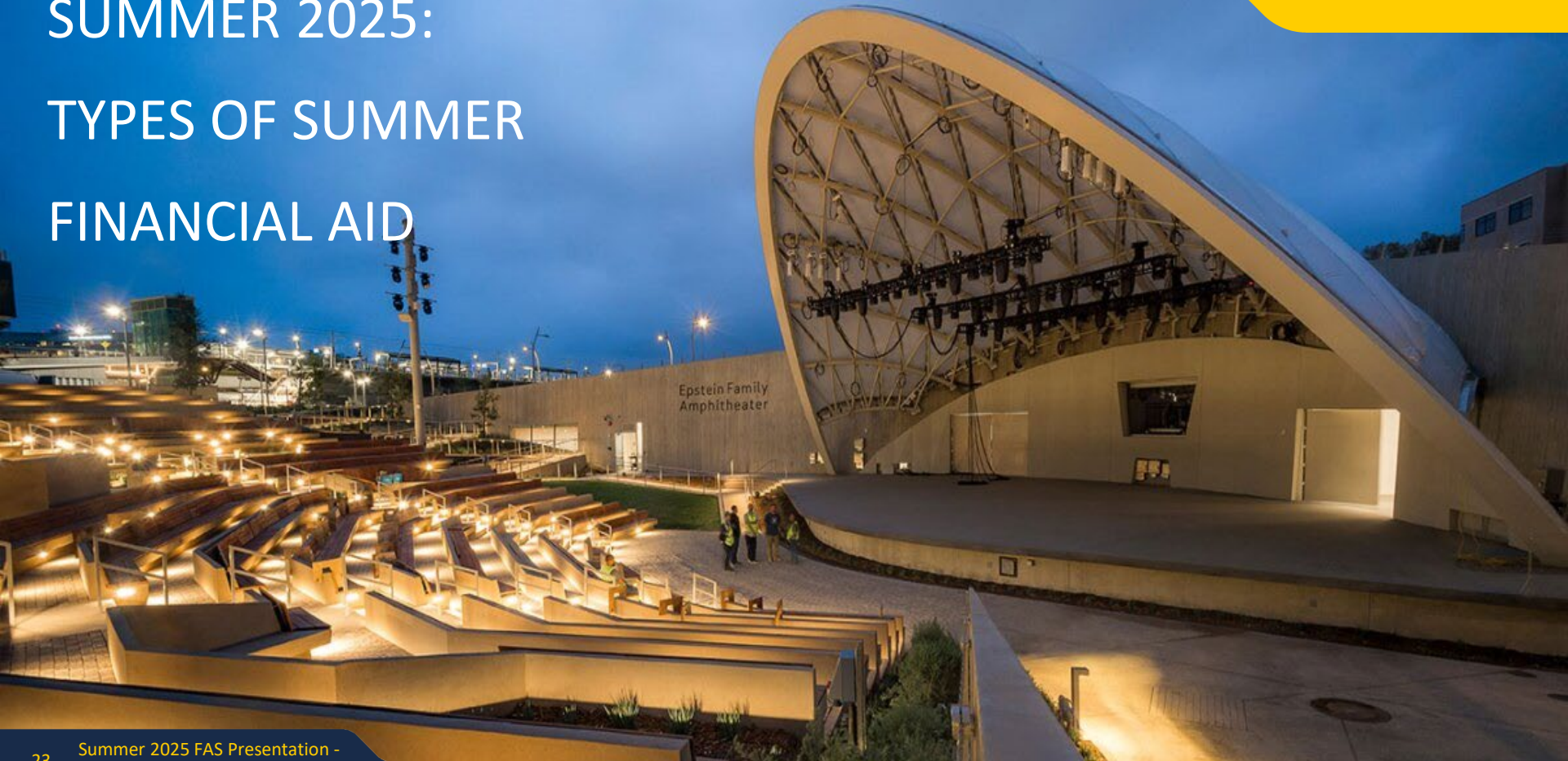
## SAP and Summer Session

- Must meet financial aid SAP standards at the end of spring 2025
  - Students may have an opportunity to appeal
  - Students are responsible for paying fees from other sources during this appeal process
- Summer Session grades count towards fall 2025 SAP
  - SAP is officially reviewed at the end of summer for the upcoming fall 2025 quarter
  - Undergraduates must maintain a cumulative GPA of 2.0 or higher, maintain the published Pace percentage, and be under Maximum Timeframe
- Students who fail to meet 2025 SAP Standards
  - Fall 2025 financial aid will be on hold
  - Students may have an opportunity to appeal
  - Students are responsible for paying fees from other sources during this appeal process

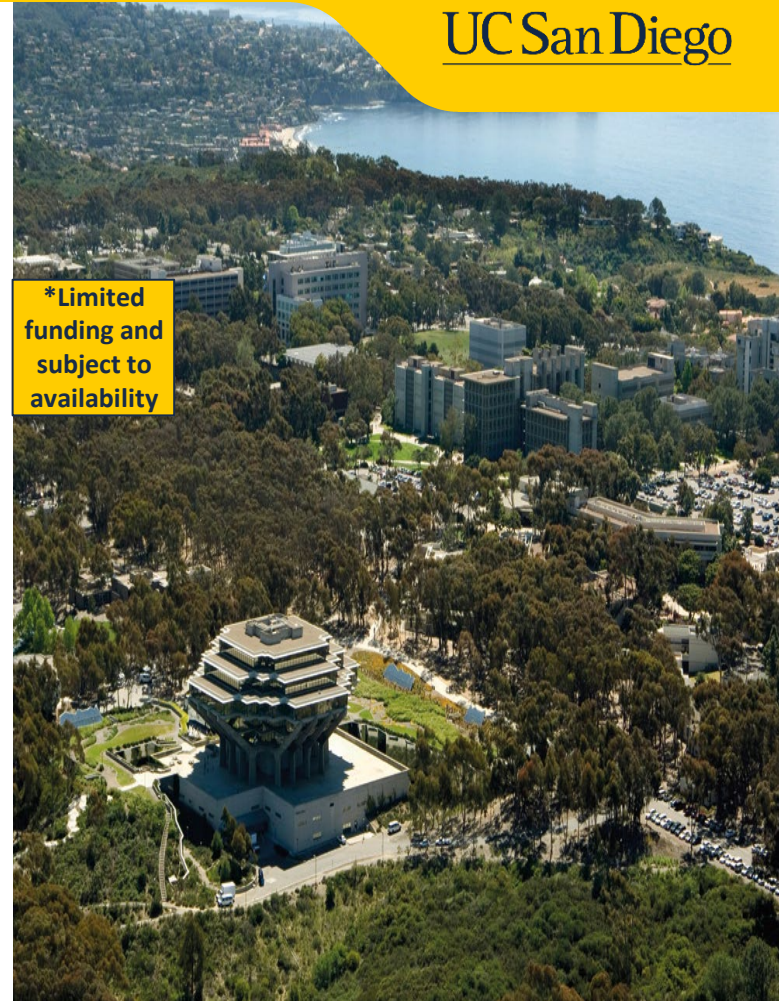

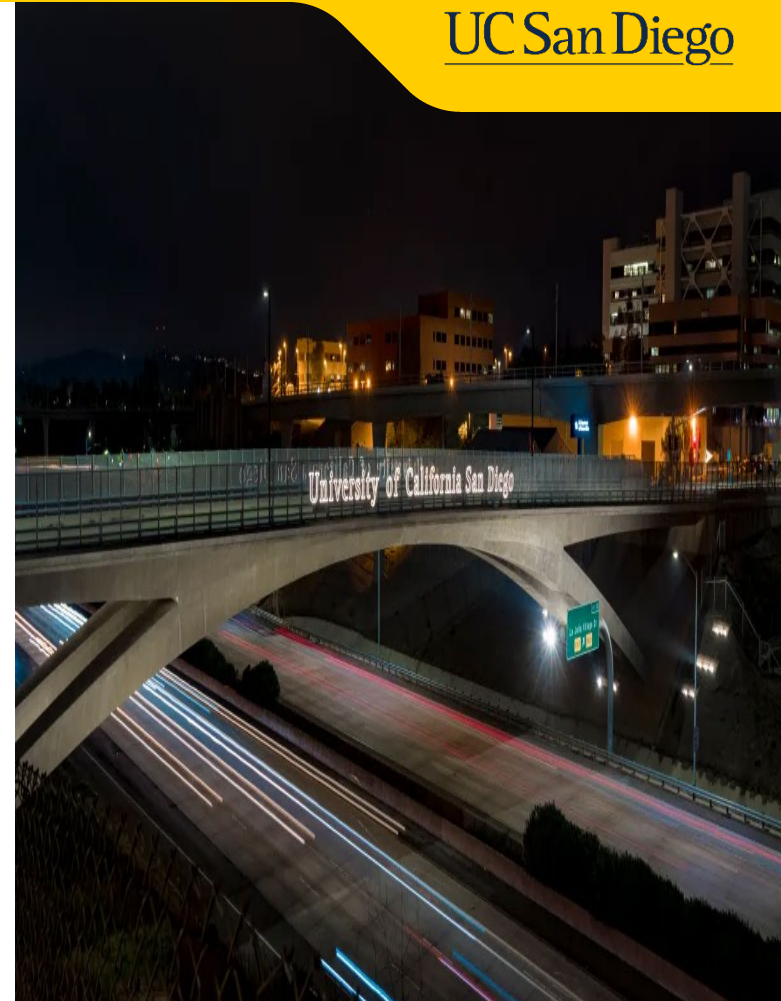

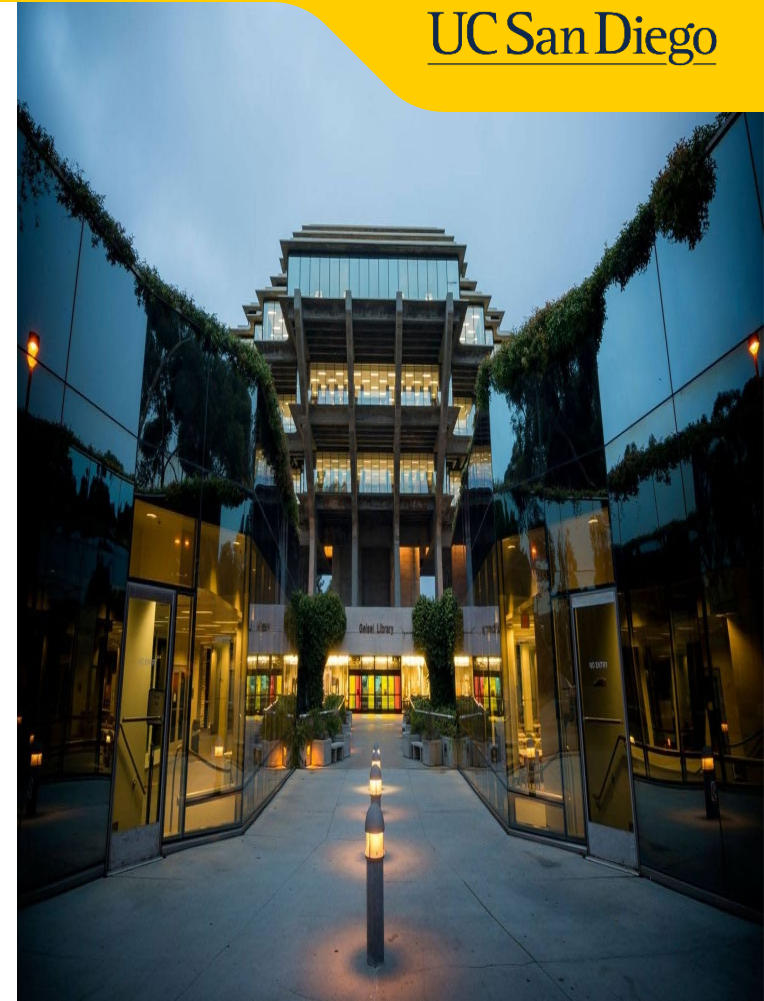

# Summer 2025: UCSD Summer Grant Overview

## UCSD Summer Grant Funding

Amount: Up to \$2,000: May be reduced by other summer grants/scholarships and/or cost of attendance

Enroll ASAP, regardless of Summer Session 1, 2, and/or Special Session

Limited funding offered to those who meet the stated requirements

Determined by the date the student enrolled in 6+ Summer Session units

Changes in summer session units after initial aid offer may result in loss of aid

**Once funding levels are exhausted the UCSD Summer Grant will cease to be offered**

On-Time application status for the academic year

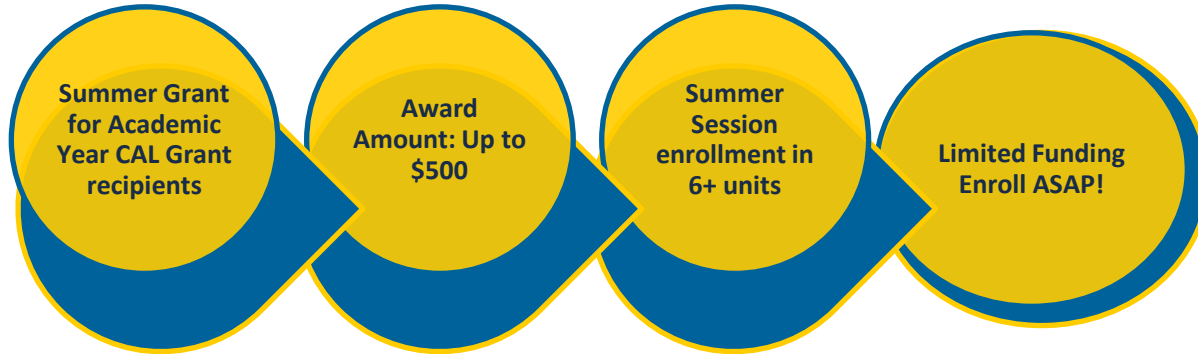

# Summer 2025: Loan Options: Interest and Fees

## Federal Loans

Self-help aid (financial aid you must repay with interest) available under varying terms and conditions.

## California DREAM Loan

- Direct Loans First Disbursed on or after July 1, 2024, and Before July 1, 2025
- Subsidized – 6.53% interest rate (6 mos. after school)
- Unsubsidized – 6.53% interest rate (while in school)
- Parent PLUS – 9.08% interest rate (while in school)

- DREAM Loans First Disbursed on or after July 1, 2023, and Before July 1, 2025
- 6.53% interest rate (6 mos. after school)
- University Loans
- 5.00% interest rate (9 mos. after school)

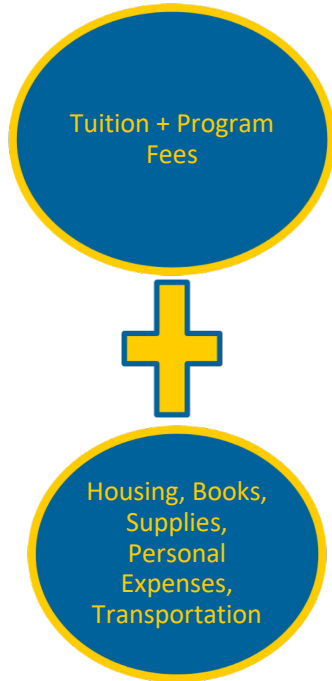

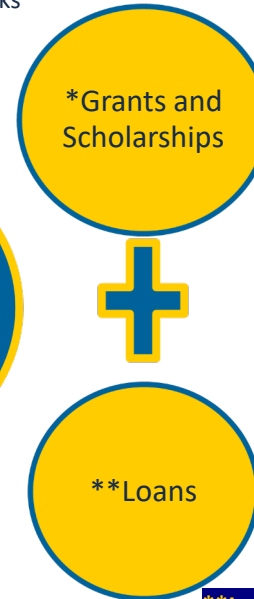

# Summer 2025: Tuition and Fees

## Tuition:

- Undergraduates: \$279 per unit
- The same price is charged regardless of out of state, non-residential, or international student status

## Campus Based Fees:

- Undergraduates: \$288.49 per Session
  - University Center Fee: \$55.43 per session
  - RIMAC Facility Fee: \$50.00 per session
  - Canyon View Facility Fee: \$11.00 per session
  - Intercollegiate Athletics Fees: \$176.06 per session (undergraduates only)
